OUR ADVOCATES WORK ONE-ON- ONE WITH GUESTS TO HELP THEM FIND PERMANENT SOLUTIONS TO THE CHALLENGES THEY FACE. AT MORE THAN 12,000 VISITS ANNUALLY, ADVOCATES ASSIST GUESTS WITH HOUSING, HOMELESSNESS PREVENTION, HEALTH AND WELLNESS CARE, EDUCATIONAL AND EMPLOYMENT OPPORTUNITIES, CLOTHING, LEGAL ADVICE, TRANSPORTATION, AND EMERGENCY FUNDS FOR EVICTION PREVENTION AND PRESCRIPTIONS.
